RESOLUTION 2023.19



A RESOLUTION ESTABLISHING THE AMOUNT OF COMPENSATION FOR ALL TOQUERVILLE CITY ELECTED AND APPOINTED OFFICERS TO BE PAID IN THE FORM OF A MONTHLY STIPEND.

RECITALS

WHEREAS in recent years due to the growth of the population of Toquerville City (“City”) and the size of the City’s administration, personnel and public infrastructure, the number of duties assigned to each elected and appointed official of the City has increased significantly.

WHEREAS due to these additional duties and responsibilities, the officials of the City (both elected and appointed) are required to devote more and more of their personal time and resources to the effective administration of City; and

WHEREAS elected and appointed officers should be fairly compensated for their time and expenses.

RESOLUTION

NOW THEREFORE, BE IT HEREBY RESOLVED by the Toquerville City Council as follows:

1. **COMPENSATION STIPEND.** The monthly compensation of the elected and appointed officials of the City shall be as follows:

a.	Mayor	\$ 1,000.00
b.	Councilmembers	\$ 300.00
c.	Planning Commission Chairperson	\$ 200.00
d.	Planning Commission Member	\$ 100.00
e.	Planning Commission Alternates	\$ 50.00

2. **TIMING AND FORM OF PAYMENT.** The Treasurer or Payroll Clerk shall pay each of the above-named City positions according to the Toquerville City Policy and Procedure Manual, as may be amended from time to time.

3. **REPEALER.** This Resolution shall repeal and supersede all prior resolutions governing the same that are in direct contradiction hereto. Planning Commission compensation will be based on attendance.

4. **SEVERABILITY.** If any provision or clause of this Resolution or application thereof to any person or entity or circumstance is held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such invalidity shall not affect other sections, provisions, clauses or applications hereof which can be implemented without the invalid provision(s), clause(s) or application(s) hereof, and to this end the provisions and clauses of this Resolution are declared to be severable.

5. EFFECTIVE DATE. This Resolution shall become effective immediately upon adoption by the City Council.


